A Guide to Making a Bequest to FAWNA (NSW) Inc.

I wish to leave a gift in my Will to FAWNA How do I arrange this?

There are three main ways a bequest may be left to FAWNA (NSW) Inc.

You can leave a fixed sum—This is the simplest form of bequest

"I give and bequeath (free of all duties) the sum of \$..... To FAWNA (NSW) Inc., P O Box 218, Wauchope NSW 2446 ABN 65 455 270 251, in aid of that charity and for its general purposes, with the written acknowledgment of FAWNA (NSW) Inc to be accepted by my executors as a full and complete discharge."

A proportion—leaving a proportion of your Estate means that your gift will not be affected by fluctuations that affect the size of your Estate.

"I give and bequeath (free of all duties)% of my Estate to FAWNA (NSW) Inc., P O Box 218, Wauchope NSW 2446 ABN 65 455 270 251, in aid of that charity and for its general purposes, with the written acknowledgment of FAWNA (NSW) Inc to be accepted by my executors as a full and complete discharge."

The residue—It is important that Wills include a residuary clause in order to dispose of any assets not specifically mentioned.

"I give and bequeath (free of all duties) the rest and residue of my Estate to FAWNA (NSW) Inc., P O Box 218, Wauchope NSW 2446 ABN 65 455 270 251, in aid of that charity and for its general purposes, with the written acknowledgment of FAWNA (NSW) Inc to be accepted by my executors as a full and complete discharge."
